By way of giving quality research laboratories and equipment, arranging for MoUs with eminent universities and institutions foreign and inland, providing incentives for researches and publications, it encourages the faculty and students. The management of SXCCE has also shown great interest in investing for researches in key futuristic research areas namely, Artificial Intelligence, Cloud Computing, Robotics, Healthcare Applications, Climate Change and Pollution Control, Renewable Energy, Image and Signal Processing, Intelligent Transportation and Emergency Response System, Smart Devices, Smart Structures, Smart Agriculture, Composite and Nano Materials, Bio-fuels, ICT enabled services etc. for building a technically empowered humane society.

# IV. <u>Guidelines/ Standard Operating Procedure/ Importance and</u> Implementation at sxcce

#### 1. Undertaking Research

Faculty members of SXCCE are expected to undertake research, leading to quality publications, obtaining research funds from various funding bodies, presentations in National/International conferences of repute, generate of Intellectual property with potential for commercialization, create socially useful outcome and other similar research activities. Academic work location relaxation will be given to faculty members who undertake sponsored projects.

# 2. Research Management

Overall management of research activities have been coordinated by CFRD, SXCCE under direct supervision of Head of the Institution and Director/Research. Research advisory board and research committee shall be responsible for overall functioning of research activities within the institute.

#### 3. Incentives for Publications & Grants

The Institute encourages quality research in different thrust areas. The incentives for journal publications in WoS and Scopus indexed journals, book or book chapter publications and research grants are provided as per SXCCE-HR Policy.



Appraisal Points for journal and book/chapter publications, various grants and patent publications are also given to the faculty members as mentioned in Faculty Performance Appraisal documents.

#### 4. Full Time Research

The enrolment of full-time research scholars plays a vital role in enhancing the quality of research in the institute which supports the vision of SXCCE and strengthens the quality of research and development in all our research centres. Scholars who are willing to pursue their Ph.D shall register at SXCCE after being provisionally registered under Anna University. They should present their research plan before the research review committee constituted by CFRD. The committee may recommend for Institutional fellowship after the assessment of his/her candidature.

#### 5. Travel grants and Dearness allowances

TA / DA norms for faculty members and staff attending any official meeting / Conference / Workshop etc. will be provided as per the SXCCE HR Policy

#### 6. Research Paper Presentation in International conferences

Financial assistance to the faculty members who attend international conferences and for present a paper will be as per SXCCE HR Policy



# 7. Seed Money for research projects / product development.

SXCCE management will consider providing seed money for research projects as per SXCCE HR Policy.

#### 8. Ethics in conducting Research

- ➤ All Researchers shall demonstrate integrity and professionalism, fairness, equity and intellectual honesty
- ➤ Appropriate credit to be provided to all members involved in the particular research work for their respective research contributions.
- Research methods and results are open to scrutiny and discussion
- ➤ All Researchers shall effectively and transparently manage conflicts of interest
- ➤ All Researchers Shall Prevent and check plagiarism through authenticated software to ensure academic integrity, originality and innovation.
- ➤ An ethical committee approved by the Principal shall implement the guidelines, ensure strict adherence and initiate suitable inquiry, investigation and disciplinary action, in case of default.
- The Institute currently adopts the plagiarism policy guidelines of the AICTE (Circular No. AICTE /P&AP /Misc./2017 dated 30.11.2017) and UGC (Circular No. F.1-18/2010-CPP-11 dated 06.08.2018 & Circular no. N.F.1-112020(SECY) dated 20.04.2020).

- Contact any approved Supervisor of SXCCE
- Get no objection certificate approval from Correspondent through the Principal
- > Submit your application form to Anna University Chennai and proceed for registration
- Submit internal SXCCE Registration form before first dc meeting to CFRD
- ➤ Submit half yearly Progress report for every semester through the Supervisor
- Before synopsis submission, provide details about the seminar presentation to issue official notification from CFRD
- ➤ Before submitting thesis, submit thesis submission form to CFRD
- ➤ Before viva voce exam, submit Ph.D. viva voce Proforma form to CFRD
